



## **BUCKING BRONCO GIVEAWAY**

## **Contest Terms & Conditions**

The Bucking Bronco Giveaway Contest (the "Contest") is being held by Grey Eagle Resort & Casino/Tsuut'ina Gaming LP and the Alberta Gaming, Liquor and Cannabis Commission ("AGLC").

Grey Eagle Resort & Casino and AGLC is holding this Contest as part of their Winner's Edge loyalty program for members who play using their Winner's Edge Cards and qualify via slot machines to electronic table games at Grey Eagle Resort & Casino between July 1 and September 23, 2025.

The Contest is open to qualifying members of the Winner's Edge loyalty program who are eighteen (18) years of age or older (each considered a "Contestant") except for employees of AGLC and affiliated advertising agencies. Registered gaming workers, casino facility directors, shareholders, managers, and facility employees, and guests that live in the same household as an employee of Grey Eagle Resort & Casino are prohibited from entering the Contest. Self-excluded players are also not eligible to participate in the Contest. Verification will be made upon contacting the winning Contestant (the "Contest Winner") to ensure they do not fall into the criteria above for members who are excluded from the Contest.

The Contest entry period (the "Contest Period") runs from 5:00 a.m. on Tuesday, July 1 to 6:59 p.m. on Tuesday, September 23, 2025 Mountain Daylight Time (MDT). All Entries must be received on or before 6:59 p.m. on September 23, 2025 Mountain Daylight Time (MDT).

There are six ways that a Contestant can enter at Grey Eagle Resort & Casino:

- 1. Contestants will automatically earn one (1) ballot into the Contest for every fifty (50) Winner's Edge base points that they accumulate through carded play on slot machines or electronic table games at Grey Eagle Resort & Casino during the Contest Period. Bonus points earned through special promotions do not count toward Contest entries.
- 2. Contestants receive one (1) free ballot into the Contest upon the first card-in at a slot machine or electronic table game per day when using their Winner's Edge card during the Contest Period no play required.
- 3. Contestants will receive 10x ballots every Monday during the Contest Period, which are earned for every \$50 total in cash wagered (with a minimum requirement of \$50 total cash wagered).
- 4. Contestants will receive 2x ballots every Tuesday during the Contest Period, which are earned for every \$50 total in cash wagered (with a minimum requirement of \$50 total cash wagered).





- 5. Contestants will receive 20x ballots every Thursday during the Contest Period, which are earned for every \$50 total in cash wagered (with a minimum requirement of \$50 total cash wagered).
- 6. Contestants may redeem fifty (50) points from their Winner's Edge member account for one (1) ballot entry into the Contest through a Winner's Edge kiosk at Grey Eagle Resort & Casino.

Ballots are only valid during the Contest Period.

Players must card in with their Winner's Edge card at Grey Eagle Resort & Casino on September 23, 2025 between 3:00 p.m. and 6:59 p.m. to activate their ballots.

Grey Eagle Resort & Casino must receive the completed and signed Contest Prize Acknowledgement and Release Form and Skill Testing Question from the Contest Winner by the date specified in the Contest Acknowledgement Letter.

There will be one (1) grand prize (the "Prize") valued at {approx. \$84,000} (Canadian dollars) to the Contest Winner:

Winner will be selected randomly through electronic draw. Contestant must be eligible to win. If contestant is not eligible then ballot will be void and a new contestant will be drawn from through electronic draw. Contestant will have two minutes to present themselves to Guest Services. If contestant does not present themselves to Guest Services within the allotted time, contestant becomes ineligible, ballot becomes void and a new winner will be drawn.

The name on the Contest Winner's ID must match the name on the winning Winner's Edge account/card. Each Contest Winner will be required to successfully complete a mathematical skill-testing question, and to sign a Contest Prize Acknowledgement and Release Form before the Prize will be awarded.
