



# SUMMER OF SPINS

1. The promotion will run from June 2, 2025 – August 25, 2025, on Mondays.
2. Guests will have the opportunity to play in a weekly slot tournament with a chance at qualifying for the Summer Finale Slot Tournament.

## CHANCES OF WINNING:

## HOW TO ENTER

- (i) Re-buys of \$5 are available up until 9:00 PM day of slot tournament.
  - (ii) Participants may not re-buy until their registered heat is completed.
- b. Participants must visit Casino Cage at Grey Eagle Resort & Casino and fill out an entry form provided.
- c. All entry forms must be completed in full to be considered valid.
- d. Participants must provide accurate and up-to-date information on the entry form.
- e. Participants will be entered into the next available heat of slot tournament.
- f. The Tournament host reserves the right to disqualify any entry form that is incomplete, illegible, or contains false information.

## SUMMER OF SPINS SLOT TOURNAMENT

- 6. Grey Eagle Resort & Casino will use specifically designated slot machines for tournament use.
- 7. Registered participants will compete in heats of 10 participants.
  - a. When a heat is filled to a maximum, registration will continue to the next heat.
  - b. Completely registered heats will be announced in the tournament area.
    - (i) Contestants will have four (4) minutes to present themselves to the Tournament Area.
    - (ii) If contestant does not present themselves to the tournament area within the allotted time, contestant will be registered into the next available heat and tournament play will continue without the contestant for the original heat.
      - i. If contestant does not present themselves for the next available heat, registration becomes void and entry/re-buy fee will be forfeited.
  - c. Heats will be played in one (1) minute sessions.
  - d. Heats will be played until registered heats are completed.
- 8. At the end of the one-minute session, the score reflecting the machine you are playing will be your final score.
- 9. All tournament participants must actively play the slot machine or face disqualification.
- 10. In the event of a machine malfunction, it will be handled on a case-by-case basis. A technician with the Alberta Gaming and Liquor Commission will be present throughout the slot tournament.
- 11. Top 20 scores will qualify for that evening's semi-finals. Cannot have multiple entries in the semi-finals and only the highest score of each individual contestant will qualify.
  - a. Semi-finals will be played in two sessions of 10 participants.
  - b. Semi-finals will be played in one (1) minute sessions.
  - c. Top 10 scores will qualify for that evening's finals.

- d. Finals will be played in a one (1) minute session.
- e. Places will be determined by the highest score in the finals receiving first place, second highest score in finals receiving second place and so on until the tenth highest score in the finals receiving tenth place.

## **SUMMER OF SPINS SLOT WEEKLY TOURNAMENT PRIZE POOL**

## **SUMMER FINALE SLOT TOURNAMENT**

13. Top 100 scores from the Summer of Spins Weekly Tournaments will qualify for the Summer Finale Slot Tournament on Monday August 25, 2025 at 6:00 PM. Only the scores of the heats (excluding scores of the semi-finals and finals) will be eligible to qualify for the Summer Finale Slot Tournament. Cannot have multiple entries in the Summer Finale Slot Tournament and only the highest score of each individual contestant will qualify.
14. Qualified entrants for the Summer Finale Slot Tournament will compete in heats of 10 participants.
- a. Qualified entrants must register starting at 2:00 pm at Guest Services.
    - (i) If qualified entrant does not register to the tournament area by 6:00 PM, contestant will be forfeit their entry into the Summer Finale Slot Tournament and qualification will be void.
    - (ii) Contestants will be announced for each Summer Finale Slot Tournament heat and have four (4) minutes to report to the slot tournament area.
  - b. If contestant does not present themselves to the tournament area within the allotted time contestant will forfeit their entry into the Summer Finale Slot Tournament and qualification will be void.
  - c. Heats will be played in one (1) minute sessions.
  - d. Heats will be played until registered heats are completed.
